**CYLINDER DISPLACEMENT**

Information provided to identify large-cylinder capacity vehicles (4 litres or more) that are subject to an additional registration fee.

2

**INITIAL QC REGISTRATION**

Date the vehicle was first registered in Québec.

3

**DATE OF WITHDRAWAL**

Date on which the vehicle was withdrawn from Québec registration; the reason (vehicle discarded, severely damaged, licensed outside Québec, etc.) is shown under "Vehicle Status".

4

**ORIGIN**

Jurisdiction outside Québec in which the vehicle was last registered, or where the vehicle was acquired from a dealership operating outside Québec.

**DESTINATION**

Province, state or country to which the vehicle has been sent following its sale to a resident of a jurisdiction outside Québec, or jurisdiction where the owner moved after cancellation of Québec registration.

6

**NO. OF KM AT ACQUISITION**

Reading available only for vehicles registered from September 10, 2001, date on which the SAAQ began recording this information. If the information is unavailable, the reason for the absence will be stated.

7

**GROSS VEHICLE WEIGHT RATING (GVWR)**

The GVWR is used to determine if a vehicle is considered as heavy within the meaning of the *Act respecting owners, operators and drivers of heavy vehicles*.

8

**DATE CEDED**

Date ownership transfer took place due to the vehicle being sold, given as a gift, the end of a long-term lease or bankruptcy.

9

**NAME OF OWNER OR LONG-TERM LESSEE**

Under the *Act respecting Access to documents held by public bodies and the Protection of personal information*, the SAAQ is not allowed to disclose the name of an individual (natural person). Only the names of legal persons (business firms or companies) may be shown.

10

**REGISTRATION**

An entry is created for every ownership transfer (owner, long-term lessee or dealer). Dealership entries are not required, being exempt from vehicle licensing.

11

**PERIODS OF USE OF THE VEHICLE**

The record entry of more than one period for the same type of use indicates that the vehicle was not licensed for the road at some point. The reason and length of time when the vehicle was not used on the road is not detailed in the record kept by the SAAQ, but usually corresponds to seasonal storage.

**Before leasing or buying a used motor vehicle, it would be wise to obtain a copy of the Vehicle Record, its real history.**

**This document provides information on:**

- the vehicle (make, model, year, number of cylinders, net weight, etc.);
- the number of previous owners;
- vehicle use (commercial, personal, taxi, etc.).

**How does one go about obtaining a record?**

- Go to an SAAQ service centre or licensing agent;
- or
- Fill out the *Vehicle Record Request* form, available on our Web site at [www.saaq.gouv.qc.ca](http://www.saaq.gouv.qc.ca) in the *E-forms* section.
